- The above un-audited results have been reviewed by the Audit Committee of the Board and taken on record at the meeting of the Board of Directors held on 2nd February, 2021. The Statutory Auditor of the company have carried out limited review as required under SEBI (Listing Obligations and Disclosure Requirements), 2015 and the related report is being submitted to the concerned stock exchanges.
- In 2018-19, the Group has recognized profit of Rs. 3,382.80 lakhs on sale of fixed assets by three subsidiaries (namely BLS E-Services Private Limited, BLS IT-Services Private Limited and BLS E-Solutions Private Limited). However, confirmation from Punjab Government is awaited.
- The WHO declared COVID 19 outbreak Pandemic, responding to which the various governments across the world including Govt. of India has taken serious measures to contain the spread of the virus by imposing "Lockdowns". The Lockdown has severely affected the International Travel and therefore our Visa Services operations have been severely affected since the last fortnight of March 2020. The Company expects to see the demand for VISA services to pick up though at moderate pace once restriction on international travel is lifted. The Operations of Punjab Seva Kendra, Consular services and Bank correspondence businesses however are back to pre-COVID levels given that these are essential services and hence not impacted by the pandemic. The group has realigned its expenses in line with the operational levels, to reduce the impact on financials. With the partial lifting of lockdown the company has started reopening its offices in phase wise manner with limited staff strength following required social distancing norms and various advisories released by the Govt.
- As approved by the board of the Company at their Board Meeting held on February 2, 2021, the Company will disburse an Interim dividend of Rs. 0.25 per equity share of the face value of Rs. 1/- each aggregating Rs. 256.13 Lakhs.
